What personal data we collect and why we collect it

IT data of general nature

When you access this website, information of a general nature is automatically collected. This information is recorded in the server log file and includes the type of web browser, the operating system, the domain name of your internet service provider, your IP address and other similar information.

This for the following reasons:

- To ensure a trouble-free connection to the website
- To ensure the smooth use of our website
- Evaluation of system security and stability

Your data will not be used to draw conclusions about your person. Information of this kind is only evaluated statistically to optimise our website and the technology behind it.

Duration of storage

The data is deleted as soon as it is no longer required for the purpose for which it was collected. This is for IT data generally the case when the respective session has ended.

Contact form

The data you enter is stored for the purpose of personalised communication. This includes the email address as well as your name and message.

Duration for which we store your contact form data

For users who write a message via the contact form, we store the transmitted information for an unlimited time.

Use of script libraries (Adobe Fonts)

To display our content correctly and graphically appealing across all browsers, we use "Adobe Fonts" (4-6 Riverwalk, Citywest Business Campus, Dublin 24, Republic of Ireland) for the display of texts.

The following data, among others, are recorded and analysed:

- The time required by the web browser to download the fonts
- The time between downloading the fonts by the web browser and applying the fonts
- Whether an ad blocker is installed to determine if the ad blocker is interfering with the proper tracking of page views
- Operating system and browser version
